 - Nature and Extent of involvement of Faculty and students in academic affairs/improvements:

Every department has a course committee which comprises of the entire teaching staff of that course / department. The Dean of the concerned department call the meeting of the course committee at regular intervals, particularly before the allocation of the courses. Teachers concerned with a particular course is asked his / her experience of the content, pedagogy and students response. Based on such inputs, minor changes are made in the



course structure. A detailed restructuring of all courses in the programme is done after every three years. As a NBA accredited institute, the institute has formulated its Programme Educational Objectives, Programme Outcomes and Course Outcomes. The course outcomes are decided by the faculty concerned which should be in tune with the PO and further to PEOs and mission and vision. The expected CO is matched with the attained outcome and significant variations are looked into.

The students' involvement is sought by periodical feedback for every course. Every class has two class representatives from whom weekly feedback is taken.

- Mechanism/ Norms and Procedure for democratic/ good Governance As stated above, the decision is not from top to bottom but it is the other way round. In this way, it is called democratic. The apex decision making body i.e. the Governing Body takes suggestions regarding infrastructure improvement faculty requirements, library and computer lab up gradation etc. from all stakeholders. Their opinion is called and complied by the Dean who in turn forwards it to the Director and the Director than places it for consideration of either the Academic Advisory Council or the Governing Board.
