- 1. To called upon to make surprise raids on hostel and other places vulnerable to incidents and having potential for ragging and shall be empowered to inspect such
- 2. To conduct on the spot enquiry into any incident
- 3. Conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts documents and view concerning the incidents of ragging, and considerations such other relevant information as may be required
