LANGUAGE LAB

A language laboratory helps students in the acquisition and maintenance of oral and written proficiency, oral comprehension and cultural awareness. It helps one to learn accent, pronunciation, stress and all other aspects of the phonetics of the language. Most of the students who do not get placement after learning hard skills are found to lack in their soft skills and find themselves incompetent to express themselves and their knowledge efficiently.

ROBOTICS LAB

A Robotics Lab of JIMS involves the MCA students who derive inclination in creating robots that may even be potent to work without human intervention. The Club conducts workshops to make students aware of mechanical, electronic, electrical and programming skills related to robotics and provides an opportunity to participate in national or international level competitions.

HOSTEL ACCOMMODATION

The institute provides well-furnished hostel facility for both boys and girls. The aim of the hostel is to make it a home away from home.

JIMS already had girls hostel but now, beginning with 1st July, 2017, Boys Hostel has also been started which has 136 beds.

It has spacious rooms with windows opening into balcony, other facilities include common room and dining room, apart from the infrastructural soundness, it provides sufficient scope for interaction and relationship-building. 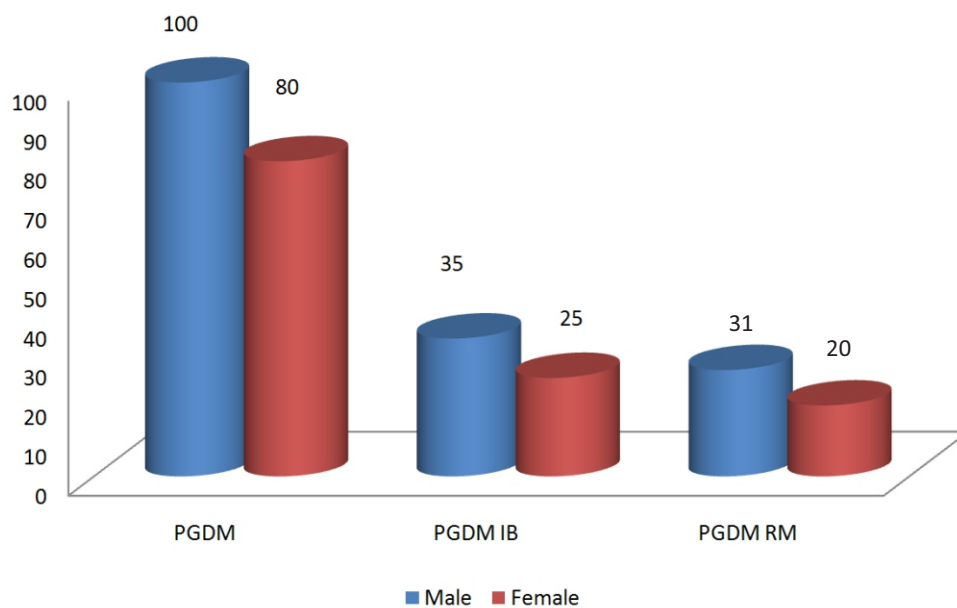
SELECTION PROCEDURE

ELIGIBILITY

MASTER OF COMPUTER APPLICATION

Bachelor degree from a recognized university in any discipline with at least 50% marks in aggregate and must also have passed in Mathematics and English at least Senior School Certificate Examination (Class XII) of the CBSE or any other examination recognized as equivalent thereto.

or

BCA/BIT/BIS from a recognized university of at least three years duration with minimum 50% marks in aggregate.

or

Bachelors Degree in Engineering or Technology or a qualification recognized as equivalent thereto with at least 50% marks in aggregate.

BACHELORS OF BUSINESS ADMINISTRATION

Passed in class 10+2 of CBSE or equivalent with a minimum of 50% marks in aggregate and must have passed in English (core or elective or Functional) as a subject.

BACHELORS OF COMPUTER APPLICATION

50% aggregate in 12th with English (core or elective or functional) and Mathematics or Computer Science/ informatics practice/Computer applications.

or

Three year diploma in a branch of engineering from polytechnic approved by All India Council for technical education and affiliated to a recognized examining body with a minimum of 50% aggregate.

SELECTION CRITERIA

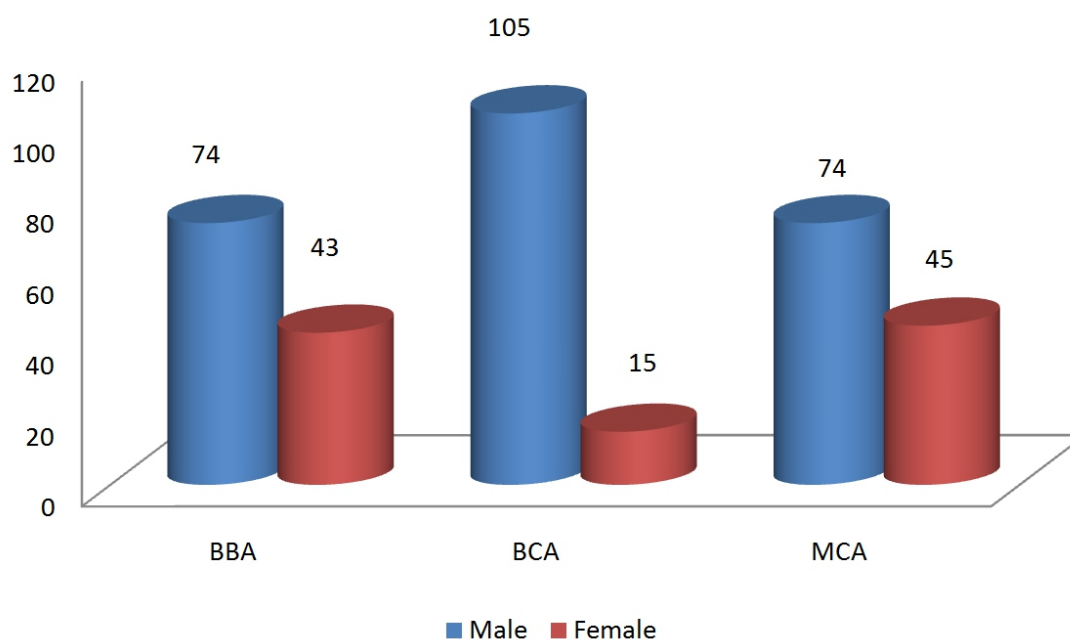
Candidates applying for MCA/BBA/BCA will have to take a Common Entrance Test (CET) conducted by Guru Gobind Singh Indraprastha University in the months of April & May, based on merit in this examination, students are admitted to the programme through Common Counselling Session.

RANK RANGE

TEACHING PEDAGOGY
